
# **DBE PROGRAM UPDATE**

Construction of the <a href="Purple Line Transit Project">Purple Line Transit Project</a> (Project) is well underway. The Project has a 22% DBE goal for Construction. <a href="Maryland Transit Solutions">Maryland Transit Solutions</a> (MTS) continues to make progress toward Disadvantaged Business Enterprise (DBE) participation on the Project. 

#### Winter Slips and Falls

As winter sets in, construction sites face unique challenges that increase the risk of slips and falls. With icy surfaces, snow accumulation, and reduced visibility, it is crucial for construction workers and Project management to prioritize safety to prevent accidents.

#### The Risks

Winter weather can create hazardous conditions on construction sites. Wet surfaces can freeze quickly, leading to slippery paths. Snow can obscure hazards, making it difficult for workers to navigate safely. Additionally, the use of heavy equipment on icy ground can increase the potential or accidents.
