




WHERE THINGS STAND

There is still a lot of work to do

Retaining/Noise Wall	\rightarrow	10% Completed
Bridges/Underpasses	\rightarrow	15% Completed
UG Utilities	\rightarrow	50% Completed
Overhead Utilities	\rightarrow	25% Completed
Mass Grading	\rightarrow	80% Completed
Roadway	\rightarrow	5% Completed
Station	\rightarrow	5% Completed
System	\rightarrow	to be further computed

ESTIMATED LEVEL OF COMPLETION >>> 35%









ENGINEERING AND DESIGN

- Design for the entire corridor is nearly complete to Release for Construction (RFC) for most civil and structural work packages.
- Final Maryland Department of the Environment (MDE) approvals are nearing completion for all design segments.
- It is the intent to complete all civil and infrastructure design prior to award of the new Design-Build Contract.

ESTIMATED LEVEL OF COMPLETION >>> 95%

ENVIRONMENTAL

- All necessary major environmental permits were obtained in 2017 and 2018 so that construction could commence.
- In some instances, additional permits (i.e., Maryland Department of Environment (MDE) Storm Water Management (SWM) and 378 permits) have been identified as needed based on the ultimate design.
- It is the intent to obtain all remaining MDE and SWM permits prior to award of the new Design-Build Contract.

ESTIMATED LEVEL OF COMPLETION >>> 95%

REAL ESTATE ACQUISITION

- The State of Maryland, through the Owner, is responsible to acquire the permanent ROW and temporary property rights necessary to construct the Purple Line from Bethesda to New Carrollton.
- The Owner has acquired the necessary ROW and property rights via negotiated purchase agreements and/or eminent domain authority.
- The acquired ROW and property rights are available for construction to the Concessionaire and Replacement Design-Build Contractor.

ESTIMATED LEVEL OF COMPLETION >>> 97%

GEORGETOWN BRANCH

(BETHESDA TO SILVER SPRING)

ALIGNMENT INCLUDES

Three (3) at-grade stations two (2) aerial stations



ALIGNMENT INCLUDES

This three-mile section continues mostly at grade except for aerial structures over Connecticut -Ave, Rock Creek Park and an undergrade crossing at Jones Mill Road.



ALIGNMENT INCLUDES

Western portion of the alignment will utilize the former Georgetown Branch of the B&O Railroad.



SILVER SPRING TO TAKOMA LANGLEY

ALIGNMENT INCLUDES

Six (6) at-grade stations, Manchester Station will be at the tunnel portal



ALIGNMENT INCLUDES

Most of the alignment is at-grade, the section at Bonifant Street has already been completed



ALIGNMENT INCLUDES

A 1,100 ft. two-track tunnel (Plymouth Tunnel)



TAKOMA-LANGLEY TRANSIT CENTER TO NEW CARROLLTON ALIGNMENT

ALIGNMENT INCLUDES

Nine (9) at-grade stations and one (1) aerial station



ALIGNMENT INCLUDES

3 underpasses (2 of which are under railroad tracks)



ALIGNMENT INCLUDES

Two (2) miles on center of University Boulevard

Several miles on dedicated ROW both at-grade and elevated structure


