

DBE PROGRAM UPDATE

Construction Phase DBE Participation (as of August 31, 2024)

Construction of the <u>Purple Line Transit Project</u> (Project) is well underway. The Project has a 22% DBE goal for construction. <u>Maryland Transit Solutions</u> (MTS) continues to make progress toward Disadvantaged Business Enterprise (DBE) participation on the Project. The bar graph below indicates the number of DBE subcontractors, and the number of DBE awarded subcontracts currently on the Project. *Note: Some contractors hold multiple contracts on the Project*

Sligo Creek Parkway Closure at Wayne Avenue


