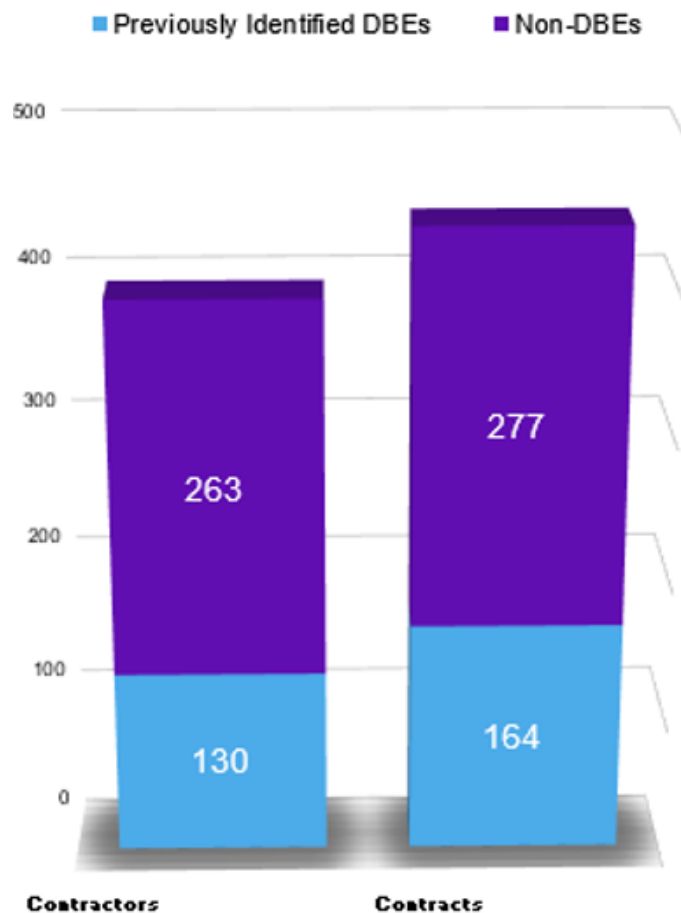
Construction Phase

(as of July 31st, 2026)

Construction of the [Purple Line Transit Project](#) (Project) is well underway. The Project's 22% DBE goal for Construction has been modified in accordance with the [Interim Final Rule \(IFR\)](#) released by the U.S. Department of Transportation (DOT) on **October 3rd 2025**. Following this review, [Maryland Transit Solutions](#) (MTS) continues to make progress toward Small Business Enterprise (SBE) participation on the Project. The bar graph below indicates the number of SBE subcontractors, and the number of SBE awarded subcontracts currently on the Project.

Note: Some contractors hold multiple contracts on the Project.

ROAD CLOSURES

The long-term closure of Arliss Street between Piney Branch Road and Garland Avenue continues. The closure is to allow crews to install utilities and construct the Purple Line's Long Branch Station. The Long Branch Library and Flower Branch Apartments parking lots along Garland Avenue will be accessed by turning north on Flower Avenue and east on Arliss Street (see detour below.) No parking locations on Walden Road and other streets will be strictly enforced. Please follow the posted signage. Work may occur 7 a.m. to 7 p.m., weekdays and weekends, as needed through spring 2026.

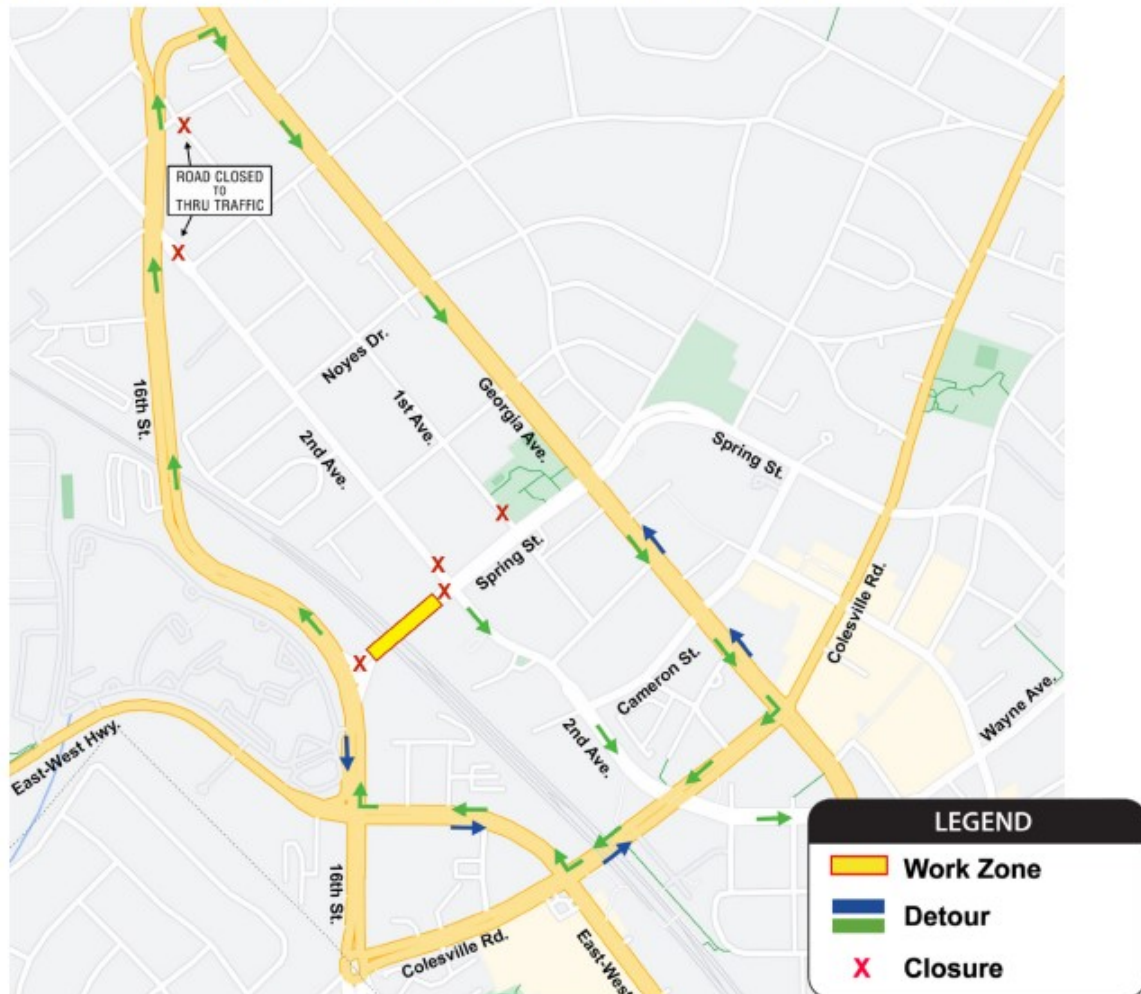

The Purple Line project anticipates completion of the Spring Street Bridge in Summer 2026. The current detour shown below will remain in place until the bridge opens to traffic. Crews continue advancing this complex structure over the active CSX and WMATA rail corridors. The main bridge span is now in place, and the deck is installed across the crossing. Currently, work focuses on constructing the reinforced concrete deck surface, building the embankments and completing approaches to the roadway, tying in the bridge to the surrounding community. Due to necessary coordination with active rail operations, some construction activities may require overnight work to accommodate CSX and WMATA train schedules. Safety remains the project's highest priority. The Purple Line team encourages all pedestrians, cyclists and motorists to follow posted signage and traffic control devices while traveling through the area.

We appreciate the community's continued patience as this critical connection moves toward completion.
